RESOLUTION #62-2024; EXECUTIVE MEMBERS OF THE COALITION OF WATERSHED TOWNS

The following Resolution was offered by Councilwoman Foote and seconded by Councilman Davenport **WHEREAS**, the town of Marbletown is located partially within that portion of the New York City Watershed that lies west of the Hudson River (the "Watershed"); and

WHEREAS, Marbletown is affected by the New York City Watershed rules and Regulations, the New York City Land Acquisition Program and other regulations and program which may be proposed in the Watershed; and

WHEREAS, Marbletown is a signatory to the 1997 New York City Watershed Memorandum of Agreement ("MOA"), which created legally enforceable commitments on issues related to New York City's watershed protection program, including the Watershed Rules and Regulations, the Land Acquisition Program, and the Watershed Partnership and Protection Programs; and

WHEREAS, Ulster County member towns each vote for two regular and two alternate Executive Committee members for two-year terms, and

NOW, THEREFORE BE IT RESOLVED that the town board of the town of Marbletown vote for Greg Vurckio from the town of Denning and David Edinger from the town of Olive as regular members and Mary Ann Van Benschoten from the town of Marbletown and Peter Disclafani from the Town of Shandaken as alternate members.

• Supervisor Parete stated that this was a policy making board of the watershed, they work with both the State and DEP. Parete added a thank you to Councilwoman Van Benschoten for agreeing to this appointment.

RESOLUTION #63-2024; AUTHORIZE SUPERVISOR TO SIGN CLEAN ENERGY COMMUNITY GRANTS

The following Resolution was offered by Councilwoman Foote and seconded by Councilman Davenport **WHEREAS**, the Towns of Rosendale and Marbletown recognize the importance of using clean energy at the Rondout Municipal Center (RMC); and

WHEREAS, the Environmental Commissions in both Towns have received grants from New York State Energy Research and Development Authority (NYSERDA); and

WHEREAS, an energy assessment is necessary to make improvements at RMC; and

WHEREAS, the Towns of Rosendale and Marbletown have an intermunicipal agreement in place for all work and services needed at RMC; and

WHEREAS, the Town of Rosendale has received and committed \$10,000 of its own grants (\$15,000 after the Disadvantaged Community adder) on the same project. Marbletown will be taking the lead on this project, with the Town of Rosendale participating through an intermunicipal agreement. The NYPA Clean Energy Solutions project will begin with an energy assessment, which will recommend further energy upgrades to the building. We anticipate that recommended upgrades will almost certainly include an upgrade of the building's electrical service and will also likely include (but will not be limited to) improvements to air sealing and insulation, replacing fossil fuel boiler(s) and hot water heaters with electric heat pump alternatives, and solar.

NOW THEREFORE BE IT RESOLVED, the Town Board of the Town of Marbletown authorizes the Supervisor to sign any documents and agreements necessary to submit Clean Energy Communities grant applications in the amounts of \$7500, \$10,000, \$20,000, and \$175,000 which NYSERDA awarded to the Town on 4/18/24 (the \$7500 grant) and 3/26/24, and

- 1) Approximately \$175,000 (with the 50% DAC adder) a New York Power Authority (NYPA) Clean Energy Solutions Project at the Rondout Municipal Center (RMC) in conjunction with the Town of Rosendale (which will be using its \$10,000 grant for this purpose).
- 2) Approximately \$10,000 on a New York Power Authority (NYPA) Clean Energy Solutions Project at the High Falls Water District.
- 3) Approximately \$110,000 (with the 50% DAC adder) for two Ford F-150 Lightning electric pickup trucks.
- 4) Approximately \$12,000 for two Husqvarna Auto mower EPOS electric robotic lawnmowers and base station for Town Park.

BE IT FURTHER RESOLVED, that all improvements recommended from these energy audits will be implemented with approval from both Towns.

RESOLUTION #65-2024; AGREEMENT WITH PAUL KENNEDY CONSTRUCTION

The following Resolution was offered by Councilman Davenport and seconded by Councilwoman Foote **WHEREAS**, the Towns of Rosendale and Marbletown would like to remove and discard the partition in the gymnasium at the Rondout Municipal Center (RMC); and

WHEREAS, Rondout Municipal Center Building Manager Joe La Fera has received three quotes for this project:

- 1. Paul Kennedy Construction of 734 2nd Ave Kingston, NY 12401 for \$5,737.62
- 2. Raeni's Restoration, LLC of Traver Road Pleasant Valley for \$6,710.25
- 3. JH Construction of 2079 Rt. 32 Rosendale for \$15,350.00; and

WHEREAS, RMC Building Joe La Fera has recommended that said quote from Paul Kennedy Construction be accepted.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Marbletown hereby authorizes the Supervisor to sign agreement with Paul Kennedy Construction which has been attached and made a part hereof; and

BE IT FURTHER RESOLVED, that this resolution shall become effective upon its passage by both the Town Board of Rosendale and the Town Board of Marbletown.

• Supervisor Parete stated that they don't have the key to remove the partition in the gymnasium and it sticks out about 5 feet. This is a safety issue for the kids playing and the pickleball players. Disconnecting the existing electricity is part of the work that will need to be done. Parete reminded everyone that this would be an RMC expense and the cost will be split between the 2 towns.

OTHER TOWN BUSINESS:

- Supervisor Parete stated that the State Comptroller's office had an auditor in the offices since February and they have made some recommendations, and concerns, to the town but have found that during their assessment nothing came to their attention to warrant further services. One issue that was brought up was that they would like to see more engagement from the board members when it comes to the vouchers. Parete shared a 'Voucher Approval Memo' that all the town board members will sign at the meetings. Parete mentioned that they also suggested Councilwoman Foote sign off on Supervisor Parete's vouchers. Councilman Davenport took this opportunity to point out, again, that when you look at surrounding towns financials and leadership Marbletown is doing the right thing financially and things are in order.
- Supervisor Parete said he and Councilwoman Foote met with Ted Fink to review the upcoming proposed local laws on Cannabis and Cell Towers which will be distributed as soon as they are ready.
- Councilman Hunt said they had a trails meeting recently and at the next meeting they will nominate a chair and a secretary. There will also be 2 sub committees, 1 for the Community Center and 1 for the new park. They will also be reviewing the programs that are going on.
- Councilman Foote mentioned she had attended the last ECC meeting and is very impressed at what they accomplish.

<u>Motion to adjourn:</u> There being no further discussion Councilman Davenport made the motion to adjourn the meeting, seconded by Councilwoman Van Benschoten; 5-0 Aye, motion carried. The meeting adjourned at 7:00pm.
